I, therefore, assume all risk of injury and/or death associated with this event. I will not hold The Party Store, LLC, its agents, owners, shareholders, employees, or anyone affiliated with Jones Party Magic, liable for any circumstances of this event.

I release and hold harmless and agree not to bring any action or suit against Jones Party Magic , its owners, officers, agents and employees "Jones Party Magic" releases from any liability resulting from any personal injury to myself, including death, or damage to my property which is caused by the breach of any express or implied warranty or the negligent act or omission of any Jones Party Magic release in the design, location, construction, inspection, maintenance and repair on or about the bounce house, inflatables and games from Jones Party Magic inventory. I hereby confirm that I am in good physical condition and do not suffer from any disabilities or physical conditions that place me or others at risk or otherwise physically inhibit participation in this event.

By this waiver and release, I assume any risk and take full responsibility and warranty of any and all claims of personal injury and death or damages to, but not listed, my use of Jones Party Magic property or engaging in Jones Party Magic activities or other activities on or near the premises on the dates the item is used.

I acknowledge that I have read, understand, and fully agree to the terms of this waiver and release and its contents. I understand and confirm that by signing this waiver and release, I have given up considerable future legal rights.
